### 1. Introduction

In 2021, MONSU Caulfield (**MONSU**) engaged OGL Group to conduct their Annual Elections, after having conducted their Annual Elections since 2015.

Glenn Donahoo was the Returning Officer for the 2021 Annual Elections and is the author of this report.

This report sets out the process by which the elections were undertaken, specifically highlighting areas that required attention by the Returning Officer and electoral participants.

An overview of the results is provided, emphasising trends and other observations.

The key issues and other areas of concern experienced in the election are discussed in detail. Finally, a set of recommendations are provided to MONSU and future Returning Officers as suggestions by which the electoral process can be improved.

### 2. Process

Pursuant to the Regulations, notice was given on 24 August that Annual Elections would be held from Monday 20 September to Thursday 23 September 2021 (see <u>Appendix 1 – Notice of Election</u>), with nominations for all positions due 5pm Tuesday 7 September. The Notice of the election was disseminated to all Caulfield students by email and was also published on the MONSU Caulfield website. An updated Notice of Election (see <u>Appendix 2 – Updated Notice of Election</u>) with the positions of NUS Delegates added was published on the MONSU Caulfield website on Monday 6 September.

In line with continued Victorian Government and University COVID restrictions, nomination forms and all other election paperwork including candidate and policy statements could only be submitted via email or an online form for these elections.

### **Candidate Nominations**

Nominations for all positions except NUS Delegates were opened at 9am on Wednesday 1 September and closed at 5pm on Tuesday 7 September. Nominations for NUS Delegates closed at 5pm on Friday 10 September.

The final notice of nominations received was posted on Wednesday 15 September (see <u>Appendix 3</u> – <u>Notice of Nominations Received & Positions Elected Unopposed</u>).

After the closing of nominations, a detailed verification process was undertaken to ensure that candidates and their nominators and seconders were eligible to participate in the election by virtue of their membership of MONSU Caulfield, their completion of the requisite number of semesters of study along with having the requisite number of units left in their course, as provided for in the Constitution and the Regulations.

The verification process resulted in all nominations being determined as being eligible.

Following the verification of nominations, all positions had at least one valid nomination received, with Queer Officer 2 only receiving one valid nomination. This led to this position being declared elected unopposed.

### At the close of the nomination period:

### 46 nominations had been received.

- 2 nominations were withdrawn
- 1 position was declared elected unopposed

### Voting

Due to COVID-19 Restrictions polling was conducted online via the MSL voting platform on the MONSU Caulfield website. To cast their vote, students needed to log onto the MONSU Caulfield website through the University's Okta Verification system and follow the prompts to the election webpage. By logging into the MONSU Caulfield website students automatically became members of MONSU Caulfield and eligible to vote.

The following table summarises the times during which students cast their votes, with the majority of votes being cast on the day polls opened.

### 3. Results

### Declarations

Results for all positions except NUS Delegates were declared at 5:52pm on Thursday 23 September, with the notice made available on the MONSU website and via an email sent to all authorised officers and independent candidates. The final declaration of all results occurred on Saturday 25 September and made available on the MONSU website and via an email sent to all candidates (see Appendix 4 – Notice of Results).

### Participation

The 2021 election recorded a higher number of students voting compared to last year's election, with 986 voters casting a total of 11,073 votes across all positions through the polling period. This is in comparison with 684 voters in the 2020 elections.

### 4. Issues

This section deals with specific problems which arose with the election process or logistics, as well as serious disputes or contentious rulings made by the Returning Officer. It is not intended to be an exhaustive account of each issue that became necessary for the Returning Officer to consider.

### Addition of NUS Delegates to election

The addition of the election of NUS Delegates occurred following clarification being sought from MONSU on Friday September 3, approximately halfway through the nomination period. While I was able to update the Notice of Election to include the election of NUS Delegates, this involved piecing together NUS and MONSU requirements in an extremely short period of time. The application of this may cause issues in the accreditation of delegates from MONSU to the NUS National Conference.

### Inadequacy of publicity rules for an online election

As I included in last year's Election Report, the move to an online election due to COVID-19 restrictions highlighted a number of issues with the publicity rules that govern the MONSU Caulfield Elections.

Currently, all election publicity must be approved by the Returning Officer, this includes private messages and other forms of like communication such as graphics and candidate statements posted online.

This resulted in the Returning Officer approving all personal messages that individual candidates distributed as soon as the relevant publicity rules came into effect.

The nature of campaigning in online elections necessitates candidates being able to directly contact individuals through messaging services and respond in a timely manner. The inability of the publicity rules to effectively account for real time campaigning through messaging services represents a significant flaw in the Election Regulations that needs to be corrected.

While I ruled that authorised message templates could be used with amendments to wording, the Regulations should not require the Returning Officer to effectively overrule the Regulations but instead should be drafted in an enforceable way.

The application of Regulation 20.2.1 and 20.2.2 mean that both the Returning Officer and ticket Authorised Officer must be authorising material that they have not seen in completed form as it is posted by each campaigner.

### **MSL Voting Platform**

The MSL voting platform has a number of positive attributes that make it appropriate for use for MONSU's Annual Elections. Its use in Australian student union elections is however still quite recent and requires further improvement to ensure it can be used with no issue. While most issues could be resolved through discussions with MSL, the inability to run test ballots or adequately view and test the election prior to polls opening remains an issue that needs to be resolved.

Further testing and development should also be completed on the ticket voting options and subsequent counting procedures, as an issue with the counting mechanism for ticket voting significantly delayed the declaration of results for NUS Delegates.

### **Election Timeline**

The timelines provided in the Election Regulations included dates that were not workable and required the Returning Officer to produce new deadlines under Regulations 9.2.1.2 and 9.2.1.3. This included the requirement for the Re-registration of tickets to occur prior to the Notice of Election.

The MONSU Student Council also held a meeting to pass these Regulations on the evening that the Notice of Election was due to be published. This resulted in the Notice of Election being published a day later than is required under the Regulation, as the Constitution prohibits modifications to the Election Regulations once the Notice of Election has been published.

### 5. Recommendations

# Recommendation 1 – That MONSU remove the requirement for publicity to be authorised by the Returning Officer

Requiring the Returning Officer to authorise publicity creates an unnecessary step in candidates campaigning, particularly online, as they cannot react live to anything that may impact their campaign but instead must wait for the Returning Officer to authorise publicity which can often occur with a long lead time.

If MONSU wishes to retain the requirement for the Returning Officer to authorise publicity, it should be restricted to physical publicity only (e.g. posters or how-to-vote sheets) based on a return to oncampus campaigning in 2022.

Regardless of whether the Returning Officer is required to authorise publicity, candidates and tickets will still be able to ask the Returning Officer whether proposed publicity is acceptable if they are unsure.

# Recommendation 2 – That the definition of publicity be changed to exclude direct person to person campaigning regardless of the method

The definition of publicity currently excludes verbal communication between one person directly to another, however no exemption is provided for the same communication in a written form. The ability of candidates to effectively campaign in an online election is significantly constrained by this exemption not being provided by the Regulations due to the fact that all direct messages require approval from the Returning Officer prior to distribution.

In order to facilitate the smooth running of elections going forward, especially given the proliferation of online messaging platforms in both online and in-person elections, all communication between one person directly to another should be excluded from the definition of publicity, regardless of the form of that communication.

I recommend that the definition of publicity should be amended to include written communication between one person directly to another. Doing so will not exempt this written communication from the Regulations governing prohibited conduct during the election period.

### Recommendation 3 – Continue to work with MSL to improve the voting module

The MSL voting module has had significant improvements made since the 2020 election due to the efforts of MSL and staff from across the Monash Student Organisations. There are still improvements that are needed to ensure it functions as well as possible within the requirements of the Regulations.

In particular the following areas should be worked on for use in the 2022 election:

- Ability to adequately test the voting platform by the Returning Officer and election staff prior to the opening of polls.
- Refinement of ticket voting options, including ensuring the Returning Officer can amend the ticket order as required.

- Modification of the election counting module to comply with the requirements of the Regulations.
- Option to ensure all voting data is anonymised including to MSL. While the current system
  where individuals voting data is not able to be accessed by MONSU or the Returning Officer is
  largely acceptable, this should be improved such that the data MSL has and can provide for
  manual recounts does not include identifiable voter data. This is particularly important if any
  data breaches occur.

### **Recommendation 4 – Modifications to Election Timeline**

As stated in the Issues section, the timeline needs to be adjusted to move the re-registration of tickets to after the Notice of Election is scheduled. The Notice of Election must be the first action to occur within the election timeline as students cannot be expected to meet deadlines that they have not been made aware of.

Additionally, the period during which nominations are open should be extended. The rise in the number of candidates requesting that their eligibility to nominate be checked has increased in the last few years, while the time it takes to confirm eligibility with the University has also increased due to additional data protection measures and the complexity of eligibility requirements at MONSU Caulfield. As such, the current 48 hour response time for eligibility requests was generally not met in 2021 with many students not receiving a response until after the close of nominations. By extending the nomination period, students will be able to have their eligibility confirmed prior to the close of nominations.

### Recommendation 5 – Reinstatement of on-campus campaigning

Regulation 32.5.6 was amended to ban any campaigning occurring on campus. While this was correctly applied in both 2020 and 2021 due to State Government COVID-19 restrictions, Election Regulations are standing documents that should not require annual changes to deal with specific circumstances. This amendment should be reversed, and if deemed appropriate, a separate clause should be inserted to provide for physical campaigning to be disallowed in circumstances where University or Government restrictions prohibit such social contact.

### 6. Conclusion

This year saw the MONSU Caulfield Elections be conducted exclusively online for the second time due to standing COVID-19 restrictions. This occurred successfully with a larger turnout of voters and significantly improved voter behaviour compared to previous years.

Thanks go to all the staff involved in running the elections, including OGL Group, MONSU, MSL and University staff who assisted in various ways throughout the election. In particular, my thanks go to Ming-En Koh and Lyn Nye.

I wish all successful candidates the very best as they undertake their new responsibilities in the coming year.
